## ARES Responds to Early July Earthquakes and Aftershocks in Southern California

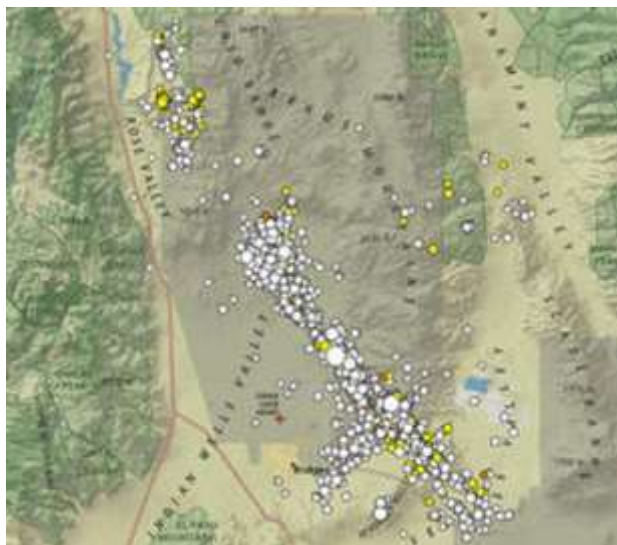
On the morning of July 4, a 6.4 magnitude earthquake rocked the California High Desert, with its epicenter near Trona in the Searles Valley, not far from Ridgecrest, population roughly 29,000. ARES volunteer Jerry Brooks, KK6PA, activated the Eastern Kern County ARES Net, and, as members assessed their own situations and were able to participate, activity grew on the Eastern Kern County ARES Emergency Net. Others filled in as Net Control Stations as the activation progressed. The Logistics Chief with the Ridgecrest Emergency Operations Center (EOC), Robert Oberfeld, contacted Eastern Kern County ARES to ask that a radio operator be assigned to the Ridgecrest Police Department mobile communications van at the EOC. Eastern Kern County ARES was able to relay information from mobile operators to the EOC regarding roadway conditions in the area, as several main highways -- including Highway 178, the only route between Ridgecrest and Trona -- had been rendered impassable. CalTrans was alerted, and repair crews had the route opened for limited traffic within a short time. As the aftershocks lessened and the extent of the damage by the first temblor had been assessed, the EOC requested that ARES stand down but remain on standby.



The next day, Friday, July 5, a 7.1 magnitude earthquake struck in the early evening. This was followed over the next 2 hours nearly 2 dozen aftershocks, ranging in magnitude from 4.5 to 5.5.

When Eastern Kern County ARES activated again, significantly more damage had occurred, with the result that fewer operators were immediately available. More subsequently came on board to provide their observations to the EOC. In all, 57 operators were active at various times on the emergency net, providing status and updates. Eastern Kern County ARES stood down from active status at 9 PM on Sunday.

"The ensuing days have brought thousands of aftershocks of generally small magnitude, but the threat of larger aftershocks remains, so Eastern Kern County ARES remains on stand by for now," said Dennis Kidder, W6DQ. Aftershocks are expected to continue for a long time, he said. -- *Thanks to Dennis Kidder, W6DQ, Eastern Kern County ARES*

**VE PROGRAM**

Brandon Hess AL6I (calling from New Brunswick, Canada) reported that he has gone through the VEC section of the website and changed the layout, so it flows better. There are still components that need a little bit of tweaking. Brandon indicated that he is looking forward to working with everyone as the new VE chairman.

**SECRETARY REPORT**

The May Board Meeting minutes and the June Membership meeting minutes were presented. With minor corrections noted and made, a motion was made by Richard Tweet KL2AZ and seconded by Keith Clark KL7MM to accept the minutes as corrected. The motion carried unanimously.

**FINANCE COMMITTEE**

Keith Clark, KL7MM indicated that there was a quick meeting. Still working on QuickBooks online. We have not heard from the individual that previously indicated he would do the club property survey. There might be a second person and Kent Petty KL5T will follow up with that individual. There has not been a rent increase from the airport. There also has been not been any additional restitution checks received.

**GRANT REQUESTS**

There were no incoming grant requests this last period.

## **GAMING**

Lara Baker AL2R indicated they are still working with the same individual on pull tabs. John Lime KL4OF talked to an equipment distributor today and resolved some of the questions we had.

## **BYLAWS COMMITTEE**

Lara Baker AL2R indicated that there are no issues right now.

## **TRUSTEE REPORT**

Keith Clark, KL7MM reported that we had a visitor on Saturday. Mark operated CW and called CQ using the club call. He made a couple of contacts in the log for us. He was impressed with the tour of the building and the extent of our facility. He is a regional manager for Vertical Bridge. Vertical Bridge is a company that has both broadcast and cell towers all over the state. He indicated that Vertical Bridge is up to speed on amateur radio and our mission. He went on to say that these towers would be available for our use. This is something to keep in mind for future projects. This past working Wednesday we opened the clubhouse for three people and one visitor, and it would be nice if more people would come out and help to spread out the work that is required to keep the RSOC operational.

Dave Webb N9AIG indicated that he did not have any requests to use KL7G. Dave went on to say that the logbook of the world for that club call is now set up.

## **PROJECTS COMMITTEE**

T.J. Sheffield, KL7TS indicated that groundskeeping was consuming most of his time. Also, Craig Bledsoe KL4E donated a 1991 Murray riding lawnmower which has been used to date to mow the grounds around the building. It has a 40-inch cut and 2 Wheel drive. TJ performed maintenance on the lawnmower by inflating the tires, topping up the oil, and re-gapping the spark plug. Dave Webb N9AIG sharpened the mower blades. Considerable time was spent mowing the lawn with only two individuals showing up for the mowing Sunday. About 5 to 7 gallons of gasoline have already been expended to mow the grounds. The grass was tall.

## **DEVELOPMENT COMMITTEE**

Lara Baker AL2R indicated that we were initially denied by the combined federal campaign because we sent in a short form of the IRS tax return and 990. It's a rational denial. The difference from the form we sent in and the whole 990 is that the board members would be included with their salaries, declaring the highly compensated individuals with salaries over one hundred thousand dollars. It's easy to answer that but we didn't have that in the form. We approached our accountant to fill out the forms and they estimated it would be something less than \$2,000. Surprising help was received from someone in California. They indicated that there are only seven sections you must fill out and he also forwarded a PowerPoint presentation indicating how to complete the forms. After a few days Lara Baker AL2R filled out the forms and resubmitted. By doing so, our status is changed to "under review." We should hear sometime in July with the disposition is on whether we have been accepted. The charge was \$17 for a publication fee and \$100 for the application fee. If accepted, we would not receive any money until April 2020. It goes to all federal employees in September. Federal personnel would give a pledge and we would then be notified in January.

Lara Baker AL2R appreciated the kind words regarding his presentation on encryption. Along those lines Lara has been asked to give the same presentation to one of the Rotary clubs on the 10<sup>th</sup> of July. He is also been asked to give this presentation to the Alaska Professional Engineers Society on the 11<sup>th</sup> of July. During both presentations, Lara AL2R will encourage monetary support for the club. TJ is also ready to give his presentation to other organizations.

## **BUILDING COMMITTEE**

Keith Clark KL7MM reported similarly to what TJ reported and that is the major activity has been mowing. We need to find a means at the general membership meeting to encourage individuals to step up and volunteer to help with maintenance of the building. Right now, there are two or three individuals that are doing all the work and burnout is a real issue. What's a shame at this point, all the efforts of a few were to perform maintenance on the building and we had no manpower left over to set up for Field Day and then enjoy the event.

## **BUILDING COMMITTEE (cont'd)**

One-on-one interactions with members have the greatest result in getting the membership to volunteer. A task list needs to be generated and posted on the website and passed around in the general membership meetings. This will be brought up in the August general meeting.

## **MEMBERSHIP COMMITTEE**

Rich Gillin AL4S is not present tonight. TJ Sheffield KL7TS indicated a manual input could be made into QuickBooks for our membership roster.

Matt Ostrander KL4QH indicated that we've been having problems for some time with CiviCRM. We should stop trying to rescue the installation of our CiviCRM. There has been an attempt to integrate multiple platforms without success. By itself, CiviCRM is an excellent stable product; but it's not stable in its current configuration. It's not reasonable to think as a club we can make this integration of multiple platforms and have it stable. Matt Ostrander KL4QH recommends that we use either Google or a simple Excel spreadsheet and move forward on that decided platform. Matt Ostrander KL4QH will have a conversation with Kent Petty KL5T and Rich Gillin AL4S to coordinate a resolution and new platform.

## **EDUCATION COMMITTEE**

Lara Baker AL2R indicated that the next eight weeks will be consumed by putting together 20 hours of instruction for the radio camp. Individuals may be asked to be either an educator or a proctor. Currently we have four students signed up for the class.

## **EQUIPMENT REPORT**

Kent Petty KL5T is not here to report on equipment. TJ Sheffield KL7TS indicated there is considerable equipment coming in, but it is not being processed or evaluated. If we're not careful the RSOC is going to start looking like Rowan Street. Lara Baker AL2R expressed an interest in keeping some nonfunctional equipment such as computers. These computers can be used in our classes as a hands-on tool so that students can disassemble equipment and see the inner workings.

## **ARES**

Ron Klein AL7JR indicated that he did a presentation for the Anchorage Rotary at the Anchorage EOC. There were about 15 people there and he gave them a tour of the radio room at the EOC. Ron Klein AL7JR has been developing a relationship with Andy Preis, the program manager. There's also a new director of the facility.
